MAP DIRECTIONS

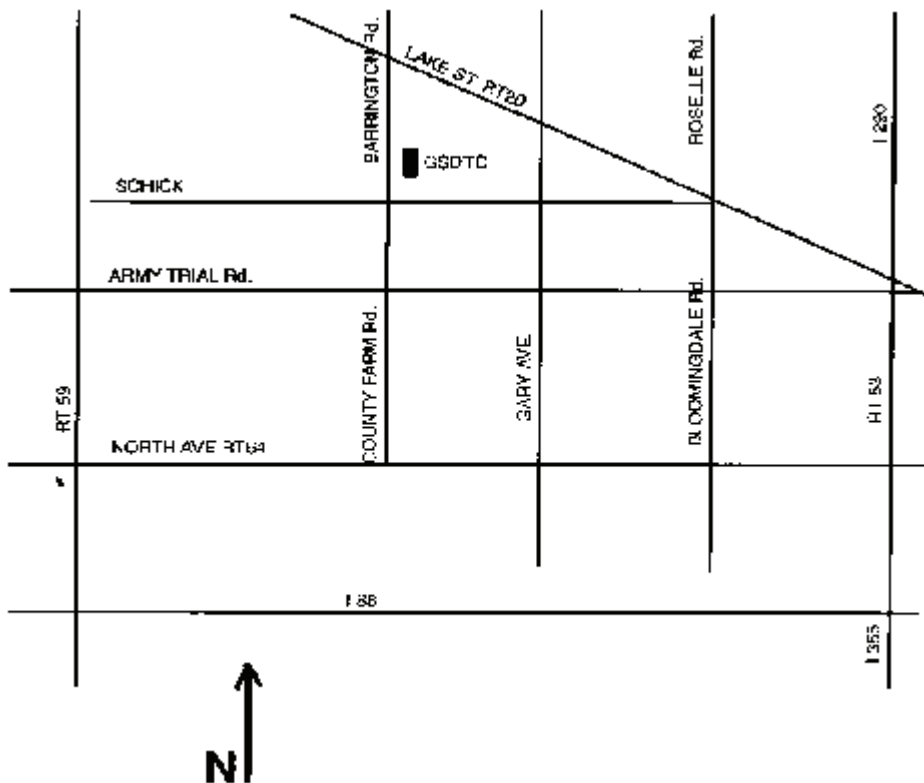
FROM THE NORTH: Take the Elgin-O'Hare Expressway to the Lake Street Exit and turn West. Take Lake Street to the first traffic light, Ontarioville Road, and turn South (left). Take Ontarioville 0.5 miles to County Farm Road and turn South. Continue South about 2 miles. GSDTC Club House (large red building) is on the East side of the road.

FROM THE SOUTH: Take Route 53, I-355 Tollway, or Route 59 to Army Trail Road. Take Army Trail Road to County Farm Road and turn North. Schick Road is the first traffic light - continue North about 0.5 mile. GSDTC Club House (large red building) is on the East side of the road.

FROM LAKE STREET: Take County Farm Road South to the Club, or take Gary Avenue off Bloomingdale Road South to Schick Road. Turn right (West) on Schick Road to County Farm. Turn right (North) on County Farm Road. Continue North about 0.5 mile. GSDTC Club House (large red building) is on the East side of the road.

FROM THE WEST: Take North Avenue (Route 64) to County Farm Road, turn left (North) on County Farm Road. Schick Road is the first traffic light - continue North about 0.5 mile. GSDTC Club House (large red building) is on the East side of the road.

FROM THE EAST: Take North Avenue (Route 64) to County Farm Road, turn right (North) on County Farm Road. Schick Road is the first traffic light - continue North about 0.5 mile. GSDTC Club House (large red building) is on the East side of the road.
